# V. State of HPLL

Total number of players for the Spring season was 354 players, which is an increase of 23 players from the previous year. There are 65 players registered for fall ambassadors and 16 players registered for the challenger league. Total for this year is 424 players served by HPLL.

The challenger league is new for this season and we will continue to make changes as appropriate. Water, shade, etc needed to ensure player safety. Anyone is encouraged to come and be a buddy for the program.

We did have travel teams this season. Scot explained the difference between the two types of teams including the extra expense, time, and equipment that are required. Those players have to pay for their own tournaments, uniforms, travel expenses, etc. There was some confusion as to the process to be on a travel team, which will be addressed prior to the upcoming season. The time commitment for these teams is also much greater than regular little league teams, up to 6 days per week during the season. HPLL does have permission from regionals and districts to continue with the program. Try outs will be held and more information will be provided to the league and is open to everyone. Those teams are not scheduled for little league games on the Saturdays that they have tournaments scheduled out of town.


